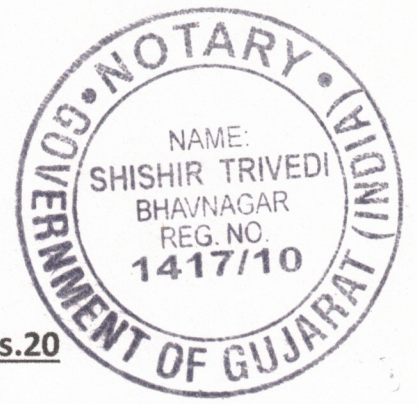

DR. K R DOSHI TRUST

THIS DEED of TRUST made at Bhavnagar his 6th November, 1999 between (I) **Shri K .R. Doshi** (hereinafter referred to as THE SETTLOR which expression shall include his heirs, successors, administrators, representatives)

AND

1. Shri Amarbhai Acharya
2. Shri Rajubhai Bambhaniya
3. Shri Kaushikbhai Pandya
4. Shri Dharmendrainsinh Gohil
5. Shri Ashish Acharya

(Herein after referred to as TRUSTEES which expression shall include their administrators, representatives and now-on-words those trustees who shall be included or relieved from the trust)

The Settlor in this deed has given Rs.51/- to this trust and settled the trust for the following general objects:

For example irrespective of caste and creed to impart education and for that purpose establish school and college, to establish laboratory and research institution, to try their best to create atmosphere for health, to give proper medical treatment to patients, to prevent diseases and for that purpose undertake scientific research. Moreover, to render help 10 mental retarded persons and to allow such other trusts having similar objects to join with this trust and for this purpose this trust has been settled.

1. Name of Trust

The name of the trust shall be Shri K.R.DOSHI TRUST and same shall be known as K.R.DOSHI TRUST.

2. Registered Office:-

Kusum Kunj, Plot No : 1878, Atabhai Road, Bhavnagar.

3. Objects of K.R. Doshi Trust:-

(A) For advancement of education, help to poor, medical treatment and financial help to economically poor trust, Shall use money from trust fund as deemed fit by the trustees.

(B) To render help to the blind, deaf and dumb and physically handicapped so that they can settle in life.

(C) To establish public hospital, clinic, medical education, nursing home and to continue these activities, establish hostels for the students and also to do important educational work viz. Start research institute, laboratories, etc.

(D) To supply to the poor their daily necessities of life viz. food and clothing and to do such other works so that poor students can raise their head with pride and live society.

(E) To-day's world's horizon has become wide, so our youth should be given knowledge of nations and international's technology viz. mechanical, electrical, electronics, civil as well as environment, health, sports and education of different languages and training. In addition to this following activities shall be done:-

- a. To provide facilities to learn different languages and training.
- b. To start laboratories for languages.
- c. To Provide Facilities for research in languages
- d. To start library having books in all the languages.

(F) To arrange for publication of above languages.

(G) For fulfilling the above objects trustees shall take appropriate action as deemed fit by them.

Any trust having above objectives can join this trust or merged with them.

4. **Jurisdiction and programs:-**

To fulfill the above objects, trustees shall make announcement for appropriate programs as they consider fit and as per these objectives trust can function in that area as they deemed fit.

5. **Board of trustees:-**

As stated earlier, Trustees shall be considered as first trustees of the trust. Moreover, in this trust minimum trustees shall be three and maximum trustees shall be eleven (11) and for any reason if there may be any vacant post remaining trustees shall

appoint a new trustee and moreover, trustees shall be appointed within the limit of eleven.

Present Trustees:-

1. Shri Amarbhai Acharya
2. Shri Rajubhai Bambhaniya
3. Shri Kaushikbhai Pandya
4. Shri Dharmendransinh Gohil
5. Shri Ashish Acharya

6. Powers and rights of Trustees

- (1) For the administration and management of trust, a Managing Trustee, Secretary, Treasurer, etc. shall be appointed. The Managing Trustee shall make appointment these posts frame rules for them.
- (2) They shall take appropriate action to fulfill the objects of the trust.
- (3) Trustees shall make arrangement for trust's fund. Sanction Budget and look after management of finance of trust and its organizations.
- (4) Trustees shall look after and movable properties of the trust and make another arrangements and these properties shall be leased or sold Or shall be used for other purposes and shall also purchase as and when required.
- (5) They shall frame rules for institutions managed by trust and changes shall be made in them, and thus they shall give guidance for the welfare and development of the trust.

- (6) For the management of trust and its other institutions, trustees shall appoint necessary advisors or sub-committee and trustees shall make changes in it or make proposals.
- (7) For the development of trust or fulfill the objectives of trust President or Managing Trustee shall discuss orally or in writing with Government or N.G.O. The President or Managing Trustees, on behalf of t rust, shall make necessary discussion with government, semi-government bodies, private bodies and foreign government or NGO for merging with them and also to execute deeds, write letters sign in such papers.
- (8) President of the Trust or Managing Trustee shall accept donation or grant from government, semi-government, NGO, foreign institution, or private individual for the development and fulfill the objectives of the trust. Moreover, for fulfilling the objectives of the trust agreement shall take loan from nationalized bank, co-operative, etc. and make agreements.

7. Meeting of the Trust:-

- (A) Managing Trustee shall preside over the meeting and in his absence. Any one from the trustees shall be the President of the meeting and he shall preside over the meeting.
- (B) The quorum of the meeting shall be 1/3 of the members present. In case there is no quorum, the meeting postponed shall be held after, half an hour and in that case quorum is not necessary.
- (C) Trustees shall appoint committees or sub-committees as considered necessary

(D) Except changes in the constitution of this trust, all the other changes shall be with simple majority. President of the meeting shall make necessary modification.

(E) For necessary changes in the constitution of this same shall be made with 2/3 majority.

8. Financial Year:-

The financial year of this trust shall be English Financial Year Commencing from 1st April and ending on 31st March and at the end of the year all accounts shall be made up-to-date.

All the above provisions shall be made as per prevailing law at that time.
